**INDIVIDUAL APPLICANT REQUIREMENTS** – Please attach the following, depending on your position

- Outdoor Industry Employee
  - "Industry" pros who currently work for an outdoor industry equipment company may apply with their active company-issued email address
  - Current Pay stub confirming employment
  - Company must be members of OIA and/or SIA and present booths annually at one or both of those shows
- PSIA Ski/Snowboard Instructor
  - If you hold a Level I, II or III, or Examiner certification card, that is all we need to see
  - Certified coaches may also apply with copies of certifications and proof of paid coaching status
  - Copy of existing certifications if previous card has expired
- Individual Guide (not AMGA, ACMG, IFMGA)
  - Resume
  - Pay stub or other documentation proving full time employment as a guide
  - Brochure and/or link to website
  - Business card
- Avalanche Professional
  - Pay stub showing full time paid status in a snow safety related line of work
  - Business card and/or copy of certifications
  - Letter of explanation of duties
- AMGA/ACMG/IFMGA Guide
  - Copy of Certification Card showing guide status
  - AMGA SPI/CWI qualifications will be accepted with proof of current employment guiding in the relative discipline

- Aspirant status will also be accepted with proof of employment in the guiding discipline
- Military/Government Employee
  - Apply using official Federal email address (can be changed after approval of application) or provide Pay Stub showing full time paid status
  - Written description/information detailing need for Gregory Packs gear (can include in "Additional Info" section of application)

## **GROUP COORDINATOR APPLICANTS**

Applying for a group account requires one person from the group to act as the coordinator for the account. The coordinator will be responsible for submitting documentation, maintaining the account relationship with Gregory, and submitting rosters when requested. The group coordinator will also be responsible for assisting us in preventing abuse of the account, and ensuring all participants adhere to the program guidelines. Orders may be forced to ship to the official group address provided on the application. Eligible programs will have a strong emphasis on wilderness and outdoor leadership training, and must offer a substantial number of backpacking-related courses and/or programs. Ski Patrol and Search-and-Rescue outfits must also apply under this category – individuals applying *on their own* from these organizations will not be accepted; no exceptions.

## **GROUP MEMBER APPLICANTS**

Once a group application has been accepted and a roster submitted, group members may apply. If you are a member of a group with a pending application, PLEASE WAIT TO APPLY until we have communicated with the group coordinator that the initial application has been approved and we have received a roster – the group coordinator will have instructions for group members to follow in order to submit individual applications at that time.

**GROUP COORDINATOR APPLICATION REQUIREMENTS** – Please attach the following, depending on your position

- Outdoor Education/Educators/Institutions
  - Brochures, links to websites, and other program related documents (schedules/course descriptions)
  - Statement describing the program's needs for Gregory Packs specifically
  - Copy of Certifications/Affiliations (AORE/AMGA/ACA/WEA etc.)
  - Copy of Site Management Plan for climbing areas used for courses (when pertinent)
  - Copy of Risk Management Plan (when pertinent)
  - Provide roster of qualified individuals with names and email addresses

- \*Individual personal orders will be allowed for full time instructors/staff requiring our gear for their work
- \*One person from the organization will coordinate the account for purchases for the program and other qualified individuals
- Ski Patrol
  - Only full time, paid, NSP Pro certified patrollers qualify at this time – please provide certification
  - Group account must be set up by the Patrol Director or acting Pro Coordinator
  - Director must submit a Roster of qualified patrollers
  - \*Patrollers do not need to submit individual documents
  - \* Patrollers may ship to individual address
- Guide Service
  - Brochure and link to website
  - Business card
  - Copies of Certifications and any other applicable documentation
  - Provide roster of qualified individuals with names and email addresses
- Search and Rescue
  - Copies of Unit or Director/Group Coordinators SAR certifications, preferably NASAR/MSAR
  - Statement describing the program’s specific needs for Gregory Packs gear
  - Provide roster of qualified individuals with names and email addresses
  - \*Individual personal orders will be allowed for highly active members to buy gear for training/missions

## Other

Rafting companies, backcountry outfitters, licensed fly-fishing guides, and other outdoor professionals may apply for a purchase group account, as well. Submit an application and provide any relative supporting documents including detailed brochure and/or website. Military and Government employed individuals may apply as a group under this category to be treated as a group, as well.
